

## Driving restrictions, goods transport Germany

**Vehicles concerned** trucks with a total permissible weight of over 7.5t, as well as trucks with trailers; The driving ban only applies to freight transports that are used for the business-like or paid transport of goods, including associated empty journeys.

**Area** throughout the road and motorway network

**Prohibition** Sundays and public holidays from 00h00 to 22h00

### Additional restrictions (summer)

**Area** the following stretches of motorway and trunk roads:

<b>A 1</b>	from the intersection Erfttal via intersection Leverkusen-West, Wuppertal, the Kamen intersection and Münster to the junction Lohne/Dinklage
<b>A 2</b>	from the Oberhausen intersection to the Bad Oeynhausen intersection
<b>A 3</b>	from the Oberhausen intersection to the Köln-east intersection, from the Mönchhof intersection via the Frankfurt intersection to the Nürnberg intersection
<b>A 5</b>	from Bad Homburger intersection to the Homberg (Ohm) junction, from Darmstadt intersection to the Karlsruhe-Süd junction and from the Offenburg junction to the Neuenburg interchange
<b>A 6</b>	from the Schwetzingen-Hockenheim junction to the Nürnberg-south intersection
<b>A 7</b>	From the Schleswig/Jagel junction to the Bordesholm interchange, from the Soltau-Süd junction to the Göttingen-North junction, from the Schweinfurt/Werneck junction via the Biebelried interchange , the Ulm/Elchingen interchange and the Allgäu interchange to the end of the federal border in Füssen
<b>A 8</b>	from the Karlsruhe intersection to the München-Obermenzing junction and from the München-Ramersdorf junction to the Bad Reichenhall junction
<b>A 9/E 51</b>	Berlin ringroad (Leipzig branch road/Potsdam intersection) to the München-Schwabing junction
<b>A 10</b>	Berliner Ring, from the Oranienburg interchange via the Pankow interchange to the Barnim interchange and from the Werder interchange to the Berlin Spandau junction
<b>A 45</b>	from the Dortmund-south junction via the Westhofener intersection and the Gambach intersection to the Seligenstadt intersection
<b>A 61</b>	from the Meckenheim intersection via the Koblenz intersection to the Hockenheim intersection

<b>A 81</b>	from the junction Stuttgart-Zuffenhausen to the junction Gärtringen.
<b>A 92</b>	from the München-Feldmoching intersection to the Oberschleissheim junction and from the Neufahrn intersection to the Erding junction
<b>A 93</b>	from the Inntal intersection to the Reischenhart junction
<b>A 99</b>	from the München-south-west intersection via the intersections at München-west, München-Allach, München Feldmoching, München-north, München-east, München-south and München/Eschenried
<b>A 831</b>	from the Stuttgart-Vaihingen junction to the Stuttgart intersection
<b>A 980</b>	from the Allgäu intersection to the Waltenhofen junction
<b>A 995</b>	from the Sauerlach junction to the München-south intersection
<b>B 31</b>	from the Stockach-east junction of the A98 to the Sigmarszell junction of the A96
<b>B 96/E2 51</b>	from the Berlin state border to the B 104 in Neubrandenburg.

**Prohibition:** Saturdays between 1 July and 31 August from 07h00 to 20h00

**Exceptions** (apply to both of the above restrictions)

1. Combined rail/road goods transport from the shipper to the nearest loading railway station or from the nearest designated unloading railway station to the consignee up to a distance of 200km (no limitation on distance during the additional summer restrictions); also combined sea/road goods transport between the place of loading or unloading and a port situated within a radius of 150km maximum (delivery or loading).
2. Deliveries of fresh milk and other dairy produce, fresh meat and its fresh derivatives, fresh fish, live fish and their fresh derivatives, perishable foodstuffs (fruit and vegetables).
3. *Transport of animal by-products acc. category 1 acc. Art. 8 as well as category 2 acc. Art. 9 f) i) of regulation (EG) No. 1069/2009*
4. *Use of recovery vehicles, tow services and breakdown vehicles in case of an accident or any other emergency*
5. *Transport of live bees*
6. *Empty vehicles in connection with transports mentioned under point 2-5*
7. Transport operations using vehicles subject to the Federal Law on the obligations of service; the relevant authorisation must be carried on board and produced for inspection on request.

Also exempted from the prohibition are vehicles belonging to the police and federal border guard, fire brigades and emergency services, the federal armed services and allied troops.

For operations which are not covered by the above-mentioned exceptions, authorisations must be obtained. These, however, will be issued only in the event of an emergency, when delivery by other means of transport is not possible.

### ***Night driving restrictions***

There exist a certain number of night driving restrictions on specific routes. These are indicated by road signs.

### ***Public holidays 2024***

03 October (Thursday)	German Unification Day
31 October (Thursday)	Reformation Day (only in Brandenburg, Bremen, Hamburg, Lower Saxony, Mecklenburg-Vorpommern, Saxony, Saxony-Anhalt, Schleswig-Holstein, and Thuringia)
01 November (Friday)	All Saints' Day (only in Baden-Wuerttemberg, Bavaria, North-Rhine Westphalia, Rhineland-Palatinate and Saar)
25 December (Wednesday)	Christmas Day
26 December (Thursday)	St Stephen's Day

Please note that at any other Public holidays in Germany than those referred to above there is no driving ban.
