The first batches will be aimed at market testing then larger volumes are expected to be required.

Initially small-scale quantities of up to 30kg for the market testing and then quantities would grow based on the future demand. Timeline being 3-5 months for the first batch This would be for a cosmetic and pharmaceutical product including vitamin A1 to be packaged in a provided airless small container/packaging.

The UK company is expecting to sign a manufacturing agreement.

Advantages and innovations

Phytoceutical have developed and patented a nano micellar water and have the data on skin delivery for retinol the first in the product range to be commercialised. Aseptic, not sterile, manufacture allows a preservative free simple formulation focussing on stability and succesful dermal delivery of the active. The formulation is fundamentally vitamin based.
